EXECUTIVE DIRECTOR - YEAR IN REVIEW

For me, the defining moment for 2020, was sitting in the Ottawa airport in late March after the Canadian Horticulture Council's Annual General Meeting talking to a few Members of Parliament from B.C. who were discussing whether Parliament would be shut down or not. That was the beginning - who could have predicted the way 2020 unfolded? It was this time last year that social distancing became a new concept. How do you work and live in small bubbles? To say that the year was unprecedented is an understatement. But

we, as humans, are adaptable and we adapted. As a sector, we were flexible, and we did what needed to be done. Food security quickly became a trending phrase in the media.

I want to express my incredible gratitude to our team at BCAC, ARDCorp and WALI. Everyone quickly adapted to working remotely and for the most part, taught themselves how to use all the virtual platforms that became a necessity. Most importantly, we continued to support the sector throughout the year, and everyone stayed safe.

I must also recognize AgSafe and their staff for their incredible help in developing the protocols and tools needed to help keep workers safe during the pandemic. Thank you!

TEAM UPDATES

The past year saw a lot of changes to staffing for us. With the departure of Ray O'Farrell who returned to Ireland with his family, we soon welcomed Darren Brown who is now leading ARDCorp's environmental programs. Darren has brought his considerable broad experience to the group and we hope you all will have more opportunities to meet Darren in person very soon.

Family and babies continue being a big part of for the BCAC team. Emma had a beautiful baby boy and is currently on maternity leave. filling her role until August 2021 is Kate Nundal. In October, Danielle returned from maternity leave and in addition to her work in communications and engagement, leading the work on developing a more structured internal policy development process at BCAC.

Melanie, who joined the BCAC Communications Team while Danielle was on maternity leave, had a COVID wedding and moved to Prince George. A big thank you to Melanie for her work and professionalism during the last year and a half. Recognizing that communications is at the core of our organization, we filled Melanie's position with a permanent role that Tristyn MacLeod has been hired for as Communications Coordinator.

What started as a six-month contract, Tatiana Travers joined the WALI team to help employers access temporary foreign workers (TFWs), She is now full-time and has become integral to our TFW support program.

STRATEGIC HIGHLIGHTS

While labour issues consumed a big part of 2020, we did make progress on other initiatives. Thanks to funding from and a partnership with Investment Agriculture Foundation (IAF), BCAC started working on a policy capacity building project. In 2020 the project had two key components; the first was the completion of an economic impact study to gather baseline data about the sector and the second was to commence building policy capacity within BCAC. Historically, BCAC relied on policy development work to be done by either our members or the provincial government. Building BCAC's policy capacity was seen as a key way to improve farmers and ranchers ability to advocate on behalf of the sector.

Since summer of 2020, we have gathered much intelligence from the BCAC membership and other general farm organizations to assist us as we develop broad sector policies. One of the key issues identified during this process was the importance of on-farm programs. The current federal-provincial agreement (Canadian Agriculture Program (CAP)) is entering year 3 of the 5-year program. Given the importance of this work to our members, we began a consultation with our members in more detail to assess how the program is currently impacting farmers and ranchers and what they would like to see in the next agreement. Policy development work will continue into 2021.

MEMBERSHIP UPDATE

A key development at the end of 2020 was the loss of two members. In December, the Society of B.C. Mushroom Growers advised BCAC that they could not pay the outstanding member dues and were withdrawing from membership. Recent consolidation of farm ownership in the mushroom sector had been creating financial pressure on the Society and resulted in their decision.

The BC Salmon Farmers Association gave notice that they would be withdrawing from membership at the end of Q1 2021. The pandemic significantly disrupted international sales of farmed salmon and farms had been selling product below the cost of production. Not long after, the federal government announced the imminent closure of several farms in the Discovery Islands region. The combination of events has resulted in the Association having to significantly reduce operating expenses, which unfortunately, included their membership to BCAC.

LOOKING AHEAD

As we look to 2021 and beyond, the key focus for the sector will be helping B.C. emerge from the pandemic stronger than before. The focus for BCAC will not be about going back to the way it was, but rather, to go forward with intentional purpose. The disruption of the pandemic has helped us take a step back and build strategic thinking back into our work so we, as a sector, can capitalize on the opportunities we currently have so we can prepare for the challenges yet to come.


PROGRAM & SERVICE DELIVERY REPORTS

COMMUNITY ENGAGEMENT (PUBLIC TRUST):

While the COVID-19 pandemic presented many challenges to the agriculture sector, it also resulted in B.C. residents showing an enhanced awareness of food system topics. We increased our virtual presence to meet our primary objective of increasing the public's knowledge and confidence in B.C.'s agriculture sector and food system while continuing to support farmers and ranchers with educational resources. Here are some of 2020's highlights:

We Heart Local BC (WHL BC)

- WHL social media channels reached over 531,000 people in 2020.
- 84% growth in new website viewership.
- BCAC Members helped us create 18 new farmer profiles, 60+ recipes, and 12 blogs.
- Over 6,000 people read our article "5 Things You Didn't Know About Farms in B.C."
- Farm and Food Care profiled three B.C. farmers in the Real Dirt on Farming.

Virtual Farm Tour

In collaboration with BC Dairy and BC Egg, WHL BC facilitated a virtual farm tour for health professionals. Upon completion of the tour, the 35 participants shared having a "very positive" impression of B.C. farmers. Farm tours will continue being a priority area of focus for connecting with the public and plans for an in-person tour late Fall 2021 are in progress.

Consumer Research

Measuring public opinion is an ongoing requirement for measuring our effectiveness. In 2020, new data was collected and when compared to the previous data (2018), there were several positive results. They were:

- Opinions of B.C. farmers remain strong.
- Significant increases in agreement that B.C. farmers are trustworthy, responsible, follow regulations, and treat their workers fairly.
- A 20% increase in consumers who agree that farmers are transparent.
- The public's general level of concern declined when asked about food system and food safety topics implying their level of trust in food production practices has increased.

Producer Workshops

CHAT Communications Workshops continued to improve producer confidence to engage with consumers in matters of public trust. Two workshops were offered in person to the BC Fruit Growers Association in January. Following the onset of COVID, the workshop was converted to a digital format, and an increased focus placed on how to engage in online conversations. Throughout the remainder of the year, four additional workshops were delivered in collaboration with BCAC member associations.

BCAC also secured funding from the Ministry of Agriculture, Food and Fisheries to host a webinar on 'Sharing Your Story' for BC farmers and ranchers. The webinar featured some CHAT communications information from Becky Parker, and other tips from dairy farmer and well-known Agvocate, Andrew Campbell. Of those who attended the webinar, 90% agree that the webinar enhanced their knowledge/skills to converse with the public about food and farming.

BC Young Farmers (BCYF) is a committee under BC Agriculture Council. BCYF assists in the transition of young farmers to board rooms and to owning farms. In social and interactive settings, BCYF members learn leadership skills, explore community development, improve agricultural awareness, explore individual talents and most importantly, meet fellow young farmers. Here are the highlights from 2020:

January - June

- Hosted a booth with BCAC at the Pacific Agriculture Show; added 37 new members.
- Seven BCYF delegates attended the Canadian Young Farmers Forum AGM in PEI;
- The committee welcomed a guest speaker for directors to present on "Robert's Rules".
- Two BCYF delegates attended the Canadian Horticulture Council AGM in Ottawa;
- BCYF launched a newsletter to improve direct communication with our members after many inperson events canceled due to the COVID-19 pandemic.
- Hosted AgSafe webinar
- Began posting diverse and original content on social media for sharing resources from our partners which as a result we have seen a great increase of engagement.
- Hosted a BCAC "CHAT" Communications webinar
- Hosted Farm Rodent Management webinar with UFV speaker.

- Hosted three (first-ever!) virtual Farm Fest events with speakers on mental health (sponsored by FCC),the economic impact of COVID (sponsored by Scotiabank), and
- innovation in agriculture (sponsored by UFV).
- Sent Christmas brief newsletter.
- Began negotiations for 2021 CAP project.




Poster from BCYF's 2020 Virtual Farm Fest

Sales Activity

For the second year since developing a new sales and marketing plan, our targets for card sales and revenue saw another increase over previous years. Thank you to our program partners for your continued support and helping us achieve our goals.





The Western Agriculture Labour Initiative (WALI) is a subsidiary company of BCAC that works with employers and governments to enable employers to find adequate domestic workers, assists employers who require temporary foreign workers (TFW) and improves working conditions for temporary workers. **Here are the highlights from 2020:**

- EMPLOYER INFO WORKSHOPS Organized two, Kelowna and Osoyoos in January 2020.
- COMMUNICATIONS: WALI WEBSITE & NEWSLETTER Updated the WALI website making it the first stop for employers looking for information on COVID-19 updates and resources. Over the course of the year, the WALI Updates newsletter became a well-known and trusted source of information for the agricultural sector in BC. There are over 1,200 subscribers.
- HUB CONNECT LAUNCH April 1, 2020 HUB Connect was officially available for seasonal workers and employers. BCAC's communication department created promotional material which was shared with workers during their 14-day initial quarantine, managed by the Province. Over 2,500 workers received the material.
- VIDEO COMMUNICATION Developed 4 videos in Spanish for TFWs:
 - Migrant Workers' Guide to Transportation in BC
 - How to Open a Bank Account in Canada
 - Safety Measures for Farm Workers Handling Pesticides
 - Employment Contracts

This was a partnership project with the Affiliation of Multicultural Societies and Service Agencies (AMSSA). Thank you, Investment Agriculture Foundation (IAF), for funding this project.

- CHARTER FLIGHTS Due to travel restrictions imposed by the Federal Government back in March 2020, WALI and MI Tierra organized charter flights from Mexico, Jamaica, and Guatemala, mobilizing close to 3,000 seasonal workers. The total arrival for SAWP workers in 2020 was 5,887.
- POLICY CHANGES AND GOVERNMENT Due to the pandemic, the Federal and B.C. Government enforced many different requirements as well as support for employers of temporary foreign workers: Employer Registry, 14-Day quarantine, financial assistance programs, COVID-19 house inspections, Industrial Camp regulations amongst other. WALI engaged with different

stakeholders advocating for employers' interests and providing critical information in a timely manner.

- **AGSTREAM** WALI has initiated discussions to collaborate with Working Link, a licensed foreign worker recruiter in B.C. as well as the Government of El Salvador.
- LABOUR MARKET IMPACT ASSESSMENT (LMIA) PROCESSING As of October 2020, WALI
 now verifies information on LMIAs with employers and confirms arrival dates (this was done by Mi
 Tierra in previous years). This change has reduced the processing times in Canada and has
 enabled much stronger connections with the Mexican Consulate in Vancouver, Ministry of Labour
 in Mexico and Service Canada. A special thank you to all parties involved in this process.
- DEVELOPING COVID HEALTH & SAFETY PROTOCOLS BCAC, AgSafe BC and Ministry of Agriculture staff worked with the Ministry of Health to develop and improve on-farm protocols to keep workers, farm families and our communities safe.



ARDCORP

BC Agricultural Research and Development Corporation

As the program delivery agent for BCAC, the BC Agricultural Research & Development Corporation (ARDCorp) serves B.C. farmers and ranchers by delivering programs, funding, and expertise to enhance the competitiveness, innovation, and viability of the agriculture sector. These effective and affordable programs and services advance both the individual producer and entire agriculture sector while benefiting local communities. ARDCorp currently administers two environmental programs, the Environmental Farm Plan Program and the Climate Action Initiative.

ENVIRONMENTAL FARM PLAN PROGRAM

Farmers who have an Environmental Farm Plan are serious about learning how to reduce agriculture's impact on the environment. Many Environmental Farm Plan participants enjoy increased efficiency and profitability as a result of increased environmental sustainability.

Despite challenges created by the COVID-19 pandemic, the 2020 EFP-BMP program year saw new heights of success. The planning advisors easily surpassed their targets for new and renewed EFPs by completing a combined total of 387 (target: 280). As well, the number of completed BMP projects more than doubled at 462 (target: 225) and saw in-excess of \$2.95 million reaching producers across the province. This includes the \$1.6 million in COVID-19 relief funding provided by the Ministry of Agriculture, Food and Fisheries in late Fall of 2020.

For the first time in this round of CAP funding, we are happy to report the successful completion of two group EFPs. The Koksilah River group EFP which focused on agriculture's role in water sustainability, whereas the Bertrand Creek Group EFP narrowed in on water quality inputs. The Bertrand Creek Group EFP also included a partnership with the Healthy Watersheds Initiative and the University of the Fraser Valley.

EFP/BMP 2020 Success Story:

The Milton's were one of the very early adopters of the EFP Program. Oscar and his adult son Terry attended an EFP workshop presentation in Vernon BC on March of 2005 and completed their first EFP for their beef cow/calf and horse operation in the Malakwa area later that year.

Over the course of 15 years, the Milton's have completed multiple EFP projects and Valley View Ranch received the BC Cattlemen's Stewardship Award in recognition for their efforts up to this point.

In 2020, they installed a centre pivot irrigation system to replace part of their wheel line and traveling gun system. With their rapidly drained soils this will help them water their crops in a timelier manner, more efficiently with less total water use.

CLIMATE & AGRICULTURE INITIATIVE BC UPDATE

2020 Highlights

- 9 Regional Adaptation Program projects completed
- 30 projects initiated or underway
- 25+ events (workshops, field days, online sessions) delivered to 715+ attendees
- 23 new resources (fact sheets, videos, reports, webinars) published and shared
- Launched the Okanagan Invasive Species Online (OISO) Application



In 2020, the Climate & Agriculture Initiative BC (CAI) focused on delivering projects for agricultural adaptation, completing nearly

10 projects and launching 13 new projects. The projects were delivered across eight key agricultural regions in B.C. and addressed a range of producer priorities, including:

- assessing water supply risks and developing informational resources for managing farm water
- preparing for more extreme conditions, including extreme heat, wildfire, flood
- evaluating and/or addressing agricultural weather data gaps

CAI supported the continuation and initiation of multiple projects to assist the sector with managing changing pest and pollinator populations. These projects included:

- Assessing water supply risks and developing informational resources for managing farm water
- Expanding the scope and breadth of co-operative pest monitoring in the Peace region, including the addition of horticultural crops for the first time
- Completing a project to deliver information on key agricultural pests in the Cariboo, including two webinars and three fact sheets
- Supporting the creation of a series of new integrated pest management guides for small-scale vegetable and berry farms
- Initiating a project in Bulkley-Nechako and Fraser-Fort George to work with local producers to gather baseline data for agriculturally important pollinators
- Initiating a project to evaluate and prioritize pest and pollinator monitoring and management needs and gaps for Vancouver Island producers

A province-wide farm and ranch wildfire preparedness project delivered five workshops to producers in January and February. It then developed a series of three videos to support farmers and ranchers in creating their own wildfire plans. The videos introduce producers to sector-specific wildfire planning resources, explain how to create an operations map for wildfire planning and response, and highlight ways to reduce wildfire risk on agricultural properties.



Major communications activities in 2020 revolved around the development of a new website for CAI, which was launched in early 2021. The website was designed to increase the accessibility of CAI resources and tools and provide comprehensive information about climate issues impacting agriculture.
